Dear Water Well Contractor:

Your water well contractor license will become inactive as of August 1, 2011 if you do not renew it prior to that date. You may apply for a two (2) year renewal of your license by completing the form below and providing the appropriate fee. The renewal fee is \$50 for complete applications (signed application form with appropriate fee) received by the District prior to August 1, 2011. The fee for complete applications received by the District on or after August 1, 2011 is \$125 (the \$50 renewal fee plus a \$75 late fee).

Water well contractors must have 12 continuing education unit (CEU) credits obtained after July 31, 2009 and approved by the Florida Department of Environmental Protection's CEU Administrator in order to qualify for license renewal. Water well contractors receiving their first license within 180 days prior to July 31, 2011, do not have to obtain additional CEU credits to renew their license for the 2011 license renewal.

Licenses not renewed prior to August 1, 2011 will become inactive. If a license remains inactive for one (1) year, it will expire as of August 1, 2012. Any application for license renewal received by the District on or after August 1, 2012 will require the applicant to complete the full licensure application process.

After receipt of the application and renewal fee, the District will verify completion of the required CEU credits with the CEU Administrator. If all licensing requirements have been met, the District will issue a new license certificate and wallet card for the 2011-2013 licensing period.

Regular employees of a political subdivision or governmental entity engaged in water well drilling shall be licensed and shall renew said license in accordance with the applicable rules but shall be exempt from paying the fees.
